

# Georgia DOR Requirements for Alcohol License Renewal

## Licensees will need:

- Citizenship Affidavit/Secure & Verifiable Document if not previously uploaded
- Bond (\$5,000.00) if not previously uploaded
- Fee
  - \$1,000.00- Winery
  - \$50.00- Special Order Shipper
  - \$50.00-Farm Winery
  - \$50.00- Broker

Inside of a GTC Log In licensees will find a listing of all their accounts under “MY ACCOUNTS”. Clicking the hyperlink that corresponds to the licensees alcohol license number will take you to the “PERIODS REQUIRING ATTENTION” page. Under the 2015 period there will be a hyperlink that says **File Renewal**. Licensees should click this hyperlink.

If a citizenship affidavit and bond for 2015 have not been filed applicants will be prompted to exit this screen and do so. If they have been filed applicants will need to answer the arrest question and click the “Next” hyper link at the top of the page in order to complete the filing of the renewal.
